

HOW TO PARTICIPATE

- 1 PRE-REGISTRATION IS REQUIRED** to participate in CleanSweepNY. Obtain a registration packet from NYSDEC by telephone at 1-877-793-3769 or e-mail to info@cleansweepny.org
- 2 RETURN COMPLETED REGISTRATION FORMS TO NYSDEC BY THESE DEADLINES: MARCH 16, 2009 FOR PARTICIPANTS WITH UNKNOWN PRODUCTS OR GAS CYLINDERS AND MARCH 27, 2009 FOR ALL OTHER PARTICIPANTS.** About two weeks before the event, participants will be sent CleanSweepNY information including drop-off date, location and time of the collection event. Participating schools will be sent packaging instructions for their materials.
- 3 Safely transport unwanted pesticides and school chemicals to the assigned collection site.** Once there, stay in your vehicle and present shipping papers that are provided with the CleanSweepNY instructions.
- 4 If you are bringing in school chemicals or if you are not a farmer or owner of a former farm and have more than 100 pounds of pesticides, please be prepared to pay a nominal disposal fee to the collection waste hauler.**

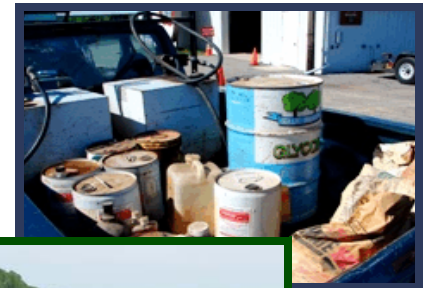

***COLLECTION OF UNWANTED PESTICIDES
AND OTHER TARGETED CHEMICALS***

CLEANSWEEPNY BENEFITS

CleanSweepNY is sponsored and administered by the NYS Department of Environmental Conservation through its Albany, NY Central Office Pesticides Program. CleanSweepNY provides the safe, economical collection and disposal of unwanted or unuseable pesticides, school chemicals, elemental mercury, and mercury-containing devices such as thermometers.

CleanSweepNY also collects and recycles triple-rinsed high density polyethylene (HDPE, #2) plastic pesticide containers from agricultural and certain non-agricultural entities.

CleanSweepNY results in enhanced stewardship of the environment through improved management of unwanted pesticides and school chemicals. These materials can pose human health risks upon exposure and a significant hazard to water resources. Through CleanSweepNY, such materials are properly collected and disposed.



To date, CleanSweepNY has collected and disposed of over 746,000 pounds of hazardous chemicals, more than 487 pounds of elemental mercury, and almost 2,200 properly rinsed pesticide containers.

The following is CleanSweepNY information on the types of materials collected, who can participate, and what materials are accepted for disposal at no or low cost.

WHAT IS COLLECTED?

- ✓ Unwanted or unusable pesticides
- ✓ School chemicals
- ✓ Elemental mercury and mercury-containing devices such as thermometers
- ✓ Triple-rinsed HDPE #2 plastic pesticide containers
- ✓ Compressed gas cylinders (which must be pre-registered and identified)

If unknown products are present, an onsite visit may be needed to assess any potential hazard. If

unknowns are needed for identification purposes, CleanSweepNY will contact you.

WHO CAN PARTICIPATE?

- ✓ Farmers and owners of former farms
- ✓ All categories of NYS certified applicators
- ✓ Schools, cemeteries, and golf courses
- ✓ Retailers of agricultural, commercial or home/garden pesticide products

CleanSweepNY collection efforts are directed towards private and professional applicators and schools, and not toward homeowners. (See household hazardous waste events information at <http://www.dec.ny.gov/chemical/8780.html>)



FREE OR LOW FEE?

- ✓ No charge to farmers or owners of former farms
- ✓ Other participants: no charge for 100 pounds or less of pesticides
- ✓ Nominal fee for each pound of pesticides over 100 pounds
- ✓ Nominal fee for non-pesticides
